# LOCAL REGULATIONS

**AS RESIDENTS OF CAROLINA BEACH, WE STRIVE TO MAINTAIN THE BEAUTY AND HARMONY OF OUR COMMUNITY. WHEN OPERATING OUR GOLF CARTS WITHIN THE TOWN LIMITS OF CAROLINA BEACH, IT'S ESSENTIAL TO BE COURTEOUS AND MINDFUL OF BOTH FELLOW GOLF CART RENTERS AND LOCAL RESIDENTS.**



## GENERAL GUIDELINES

- **OBEY ALL LOCAL LAWS AND REGULATIONS REGARDING GOLF CART OPERATION.**
- **DRIVE ONLY ON ROADS WITH SPEED LIMITS OF 35 MPH OR BELOW.**
- **AVOID RESTRICTED AREAS SUCH AS SPECIFIED BRIDGES AND BEACHES.**
- **REFRAIN FROM DRIVING UNDER THE INFLUENCE OF ALCOHOL OR DRUGS.**
- **ONLY AUTHORIZED DRIVERS OVER 18 WITH VALID LICENSES MAY OPERATE THE CART.**

# USER AGREEMENT

**TAKE RESPONSIBILITY FOR ANY MOVING OR PARKING VIOLATIONS:**  
AS RESPONSIBLE MEMBERS OF THE CAROLINA BEACH COMMUNITY, WE ASK THAT YOU TAKE OWNERSHIP OF ANY MOVING OR PARKING VIOLATIONS INCURRED WHILE OPERATING OUR GOLF CARTS. BY RESPECTING TRAFFIC LAWS AND PARKING REGULATIONS, WE CONTRIBUTE TO THE SAFETY AND ORDERLINESS OF OUR STREETS AND NEIGHBORHOODS.

**KEEP THE CART OFF BEACHES AND OUT OF WATER TO PREVENT DAMAGE:**  
OUR PRISTINE BEACHES ARE ONE OF CAROLINA BEACH'S GREATEST ASSETS, AND IT'S IMPORTANT TO PRESERVE THEIR NATURAL BEAUTY. PLEASE REFRAIN FROM TAKING THE GOLF CART ONTO THE BEACH OR INTO THE WATER TO PREVENT DAMAGE TO BOTH THE VEHICLE AND THE DELICATE COASTAL ECOSYSTEM.

**MAINTAIN THE CART'S ELECTRIC CHARGE AND AVOID DRIVING IN WET CONDITIONS:** TO ENSURE OPTIMAL PERFORMANCE AND LONGEVITY OF OUR ELECTRIC CARTS, WE ENCOURAGE YOU TO MAINTAIN THE VEHICLE'S BATTERY CHARGE AND AVOID DRIVING IN WET CONDITIONS WHENEVER POSSIBLE. THIS NOT ONLY SAFEGUARDS THE CART FROM POTENTIAL DAMAGE BUT ALSO ENHANCES YOUR OVERALL DRIVING EXPERIENCE.

**UNDERSTAND AND COMPLY WITH THE CHARGING PROCEDURE, USING A 20 AMP OUTLET WITHOUT EXTENSION CORDS:**  
FAMILIARIZE YOURSELF WITH THE PROPER CHARGING PROCEDURE FOR OUR GOLF CARTS TO MAXIMIZE EFFICIENCY AND SAFETY. UTILIZE A DEDICATED 20 AMP OUTLET FOR CHARGING, WITHOUT THE USE OF EXTENSION CORDS, TO PREVENT POTENTIAL HAZARDS AND ENSURE EFFECTIVE CHARGING CYCLES.



# CHARGING PROCEDURE

**MONITOR THE VOLTAGE METER TO GAUGE BATTERY STATUS:** THE VOLTAGE METER LOCATED ON THE GOLF CART DASHBOARD PROVIDES VALUABLE INFORMATION ABOUT THE BATTERY'S CURRENT STATUS. BY REGULARLY MONITORING THE VOLTAGE METER, YOU CAN ASSESS THE REMAINING CHARGE LEVEL AND PLAN YOUR CHARGING ACCORDINGLY. THIS HELPS PREVENT UNEXPECTED BATTERY DEPLETION DURING USE AND ENSURES A SMOOTH DRIVING EXPERIENCE.

**USE A 20 AMP OUTLET FOR CHARGING TO AVOID ANY ISSUES:** WHEN CHARGING THE GOLF CART, IT'S ESSENTIAL TO USE A DEDICATED 20 AMP OUTLET TO ENSURE EFFICIENT AND SAFE CHARGING. THIS TYPE OF OUTLET PROVIDES SUFFICIENT POWER TO FACILITATE THE CHARGING PROCESS WITHOUT OVERLOADING THE ELECTRICAL CIRCUIT. ADDITIONALLY, USING A 20 AMP OUTLET HELPS PREVENT POTENTIAL ISSUES SUCH AS OVERHEATING OR CIRCUIT TRIPPING, ENSURING A RELIABLE CHARGING EXPERIENCE.


### Trouble Shooting Review

*When your battery charging system is activated, the battery status indicator provides charging information utilizing two (2) **Amber LED** indicators, three (3) **Red LED** indicators, and one (1) **Green LED** indicator.*

**Battery Type Indicators:**

Two (2) **Amber LED** indicators are provided in order to display what type of battery the charger has been programmed to charge.

**Battery System Percent Charged Indicators:**

Four (4) LED indicators are provided in order to display the progress of the charge cycle in percentage of charge.

Illuminated LED Indicators / LED Indicator Sequence	Indicator Meaning
1 <sup>st</sup> <b>AMBER</b> LED	Configured for <b>PROVolt</b> ™ Algorithm
2 <sup>nd</sup> <b>AMBER</b> LED	Configured for Other (see page 13)
1 <sup>st</sup> <b>RED</b> LED	Charging—Initial Charging
1 <sup>st</sup> & 2 <sup>nd</sup> <b>RED</b> LEDs	Charging—60% Complete
1 <sup>st</sup> , 2 <sup>nd</sup> , and 3 <sup>rd</sup> <b>RED</b> LEDs	Charging—90% Complete
BLINKING <b>GREEN</b> LED	Finishing Stage
STEADY <b>GREEN</b> LED	Charge Complete— <b>Float</b> /Maintenance Mode





# CHARGING PROCEDURE

- 30 & 60% Red LED's Blinking.....Forming Stage Timeout Shutdown
  - This indication occurs if the battery voltage has not risen above 1.75 volts per cell (42 volts on a 48 volt pack) within the first 3 hours of charging. This indicates a possible battery issue
- 30, 60 & 90% Red LED's Blinking.....Overall Timer Shutdown
  - This indication occurs if the charger has not completed the charge cycle within the allowable factory set time period (usually 18 hours). This indicates a possible battery issue
- 30 & 90% Red LED's Blinking.....Internal Overtemp Shutdown
  - This indication occurs if the charger circuitry has detected operating temperatures inside the charger enclosure that are above the factory specified limits. Usual indicates an issue with the fan
- 30% Red & 100% Green LED's Blinking.....Bulk Stage Shutdown
  - This indication occurs if the battery voltage does not rise properly during the bulk stage
- 30% Red & 100% Green LED's Alternate Blinking On Off.....No Battery Detected
  - This will be the normal indication when a charger is plugged in A/C, but not connected to a battery
